

End User License Agreement (EULA)

Oracle Health Dashboard v1.0.0 — Please read this agreement carefully before using the software.

IMPORTANT: By installing, copying, or using Oracle Health Dashboard, you agree to be bound by the terms of this End User License Agreement. If you do not agree to these terms, do not install or use the software.

1. Grant of License

Rarexa ("**Licensor**") grants you ("**Licensee**") an **annual subscription**, non-exclusive, non-transferable, limited license to install and use Oracle Health Dashboard ("**Software**") on a single computer (identified by its hardware ID) for your internal business monitoring purposes.

A **single license key is valid for one machine only**. Deploying the same key on multiple machines is not permitted. The number of databases that may be monitored depends on the **edition purchased** (e.g. Desktop up to 3 databases; Server up to 25 databases; Enterprise unlimited).

1.1 Term, Renewal and Grace Period

The license is granted for a **twelve (12) month term** from activation and includes all updates and support released during that term. To keep using the Software after expiry, the Licensee must **renew** the subscription.

After the expiry date a **fourteen (14) day grace period** is granted, during which the Software keeps working while showing a renewal notice. After the grace period, monitoring functions are suspended until renewal.

The Licensee's configuration and history are **not deleted** on expiry. A **15-day free trial** is available before the first activation.

2. Permitted Uses

- Install and use the Software on one computer per license.
- Monitor Oracle databases owned or managed by the Licensee or the Licensee's employer.
- Create backup copies of the executable for archival purposes.
- Use in a professional services capacity to monitor client databases, provided each deployment uses a separate license.

3. Restrictions

- **No redistribution.** You may not distribute, sell, sublicense, rent, or lend the Software or license key to any third party.
- **No reverse engineering.** You may not reverse engineer, decompile, or attempt to derive the source code of the Software.
- **No modification.** You may not modify, adapt, or create derivative works based on the Software.
- **No sharing license keys.** Keys are hardware-bound. Sharing or publishing license keys is prohibited.

4. Trial License

The Software may be used in trial mode for **15 calendar days** from first launch without a license key. All features are fully functional during the trial. After expiration, a valid license key must be entered to continue use.

5. Intellectual Property

The Software and all associated materials are and remain the exclusive intellectual property of Rarexa. This Agreement does not transfer any ownership rights to the Licensee.

6. Data and Privacy

The Software operates entirely within the Licensee's infrastructure. Rarexa does not collect, access, or transmit any database metrics, connection details, or personal data. The Software contains no telemetry or analytics.
